Part 2: Programme Overview

The programme focuses on preparing individuals to become knowledgeable, competent, resilient, flexible and professionally accountable veterinary nurses who may be eligible to apply to join the RCVS Veterinary Nurse Register for employment in the UK Veterinary Industry. The student will gain a strong educational basis, integrated with professional competences.

Students will be encouraged to work as independent learners, developing analytical and reflective skills that will benefit them throughout their programme, during further academic study, and employment as veterinary nurses.

The programme will prepare the learner with a foundation for lifelong learning and:

1. Establish a knowledge and understanding of companion animals in health and disease and apply this knowledge in the context of present-day veterinary nursing environment
2. Provide students with the specialist knowledge, understanding and skills required to fulfil the role of a Registered Veterinary Nurse, to include, but not limited to: nursing care, surgical nursing, diagnostic imaging, laboratory skills, communication with clients and colleagues, and teamwork
3. Develop vocational skills, knowledge and understanding which enables students to be competent to the most recent PAB industry standards (RCVS)
4. Develop coaching skills to prepare for career opportunities as Clinical Coaches in veterinary environments
5. Provide a higher level of veterinary nursing education, exposing students to applicable research, allowing students to think constructively and critically, discuss and evaluate concepts and theories in the field of veterinary nursing, propose sound and reasoned solutions to problems and show clear developments of these skills
6. Provide students with the ability to transfer skills to different working environments and enable students to be adaptable to the changing demands of veterinary business
7. Develop skills and qualities appropriate to all aspects of personal and working life by completing part of their study in a work environment
8. Encourage a culture of self-care and resilience through development of self-awareness via academic support, mentorship and peer support to allow career longevity and satisfaction
9. Meet the needs of the UK industry sector providing the foundation for a range of careers
10. Provide students with an intellectual challenge based on a scientific and analytical approach
11. Assess the abilities of the students in a rigorous and constructive way
12. Enable students to progress into postgraduate study or research.

The BSc (Hons) Equine Veterinary Nursing graduate will have achieved all of the learning outcomes identified in the modules, including completion of a minimum of 1800 hours in an approved veterinary practice setting (minimum of 37 hours per week).

The veterinary practice learning in an equine veterinary practice allows students to develop their practical veterinary nursing competences in a variety of nursing contexts, in addition to the opportunity to develop career-long professional relationships and future employment opportunities.

The Veterinary Nursing modules validated as part of this programme are accredited by the professional body, The Royal College of Veterinary Surgeons (RCVS), and on successful completion students may be eligible to apply to enter the Veterinary Nurses Register.

Learning, Teaching and Assessment Journey:

On the BSc (Hons) Equine Veterinary Nursing programme teaching is a mix of scheduled, independent and veterinary practice-based learning in an equine veterinary practice. Students are taught at Hartpury by RCVS Registered Veterinary Nurses or Veterinary Surgeons with industry experience. Clinical Coaches offer support whilst students undertake learning in a veterinary nursing training practice. Clinical Coaches undertake training and standardisation, both of which are offered by Hartpury.

Scheduled learning includes lectures, seminars, tutorials, project supervision, demonstration, practical classes and workshops; veterinary practice learning.

Independent learning includes hours engaged with essential reading, case study preparation, assignment preparation and completion etc.

Veterinary practice learning will include 1800 hours in an RCVS Approved Veterinary Nursing Training Practice.

RCVS Veterinary Nursing Registration

Students who have completed all elements of the programme in no less than 2990 hours may be eligible to apply for RCVS Veterinary Nursing registration. This includes completing 1800 hours (of no less than 37 hours per week) in an RCVS Approved Veterinary Nursing Training Practice for the duration of the veterinary practice-based learning in stage 2.

The purpose of the programme is to provide a balance of vocational and academic study that is intellectually challenging, vocationally relevant, and provides a foundation for pursuing a career within veterinary nursing. The programme encompasses the RCVS Day One Skills and Competences for Veterinary Nurses and, on successful completion of the programme, the student may be eligible to apply to join the RCVS Register of Veterinary Nurses.

In the honours degree programme, academic knowledge and understanding will reinforce and support the development of vocational skills to equip the student with the skills and knowledge relevant to their employment and to the needs of employers. Level 6 study enhances a student's ability to think critically, allowing application of these skills within the industry. One benefit of this could include competent communication of research outcomes to appropriate audiences, to benefit knowledge exchange within the industry. Experience of coaching Level 4 student veterinary nurses provides graduates with the basis to develop as Clinical Coaches in Veterinary Practices. There has been substantial dialogue with the veterinary industry and the Royal College of Veterinary Surgeons (RCVS) thus identifying current needs in veterinary nursing and associated professions. Only on successful completion of all of the compulsory modules, and graduating, will the student become a qualified veterinary nurse and be awarded BSc (Hons) Equine Veterinary Nursing. The programme design is unique to ensure the best learning experience for students.

Stage 1 modules provide the student with a fundamental understanding of veterinary nursing techniques, as well as developing emerging investigative skills for research. Stage 2 is spent completing 1800 hours of work experience (minimum of 37 hours per week), developing vocationally relevant practical skills in an RCVS approved Veterinary Nursing Training Practice. Students complete a Nursing Progress Log (NPL) to evidence

their development against the RCVS Day One Skills and Competences for Veterinary Nursing and expected Professional Behaviours and Attributes. Students are supported in the clinical environment by a Clinical Coach and other qualified and registered colleagues, as well as being allocated a Clinical Tutor based at Hartpury for the duration of their veterinary practice-based learning.

The remaining Level 5 modules are delivered in Stage 3. These modules build on students' clinical skills, exploring surgical veterinary nursing, anaesthesia, diagnostic imaging and laboratory diagnostics. Students can access the Veterinary Nursing Clinical Skills Centre and are given the opportunity to demonstrate the clinical competence evidenced within their Nursing Progress Log (NPL) by sitting an OSCE examination. Stage 3 further builds on research skills, supporting students in developing skills in analysis and evaluation.

Stage 4 includes a research project module, allowing students to work independently to plan and execute a well-designed research inquiry, with support from a project supervisor. Professional veterinary nursing continues into this final year of study, with an opportunity to coach Stage 1 student veterinary nurses, preparing students for Clinical Coaching roles in the veterinary industry after graduation.

The diversity of experience and transferable skills acquired will give BSc (Hons) graduates a good foundation for Continuing Professional Development.

The programme is designed to facilitate student progression in a timely manner, whilst also maintaining standards. Students who do not pass the Level 5 module Veterinary Nursing in Practice 2 are prevented from enrolling onto The Veterinary Nursing Coaching Practitioner module at Stage 4, as this module includes coaching of Stage 1 students. The programme design does allow students to enrol onto a retake of Veterinary Nursing in Practice 2 in their fourth year (subject to Programme Examination Board agreement), with a sit opportunity occurring prior to the Semester 2 enrolment window for The Veterinary Nursing Coaching Practitioner. This prevents students having to return for an additional year.

Students are provided with learning opportunities in equine veterinary practices, and are supported through study skills sessions and visiting speakers. Hartpury must obtain permission from the Training Practice's (TP) Primary Centre before the student can commence their veterinary practice-based learning.

The professional and vocational nature of this programme requires that students are fit to practise and may be eligible to apply to enter the RCVS, Veterinary Nursing Register on graduation from the university. If students are deemed to be unfit to practise at any point during their programme of studies the current version of the University 'Professional Suitability' annex of the Academic Regulations will be followed to protect the integrity of the award. Reference will be made to the RCVS Veterinary Nursing Fitness to Practise guidance. Students can view the 'Professional Suitability' process by accessing the academic regulations, via the Hartpury website, and navigating to the appropriate annex.

For modules that link to the RCVS Day One Skills and Competences for Veterinary Nurses and Professional Behaviours and Attributes there are limits to the reasonable adjustments to assessment arrangements that can be made. These modules are marked with an asterisk in the Programme Structure table in Part 3. For these marked modules changing assessment type is not permitted and other adjustments, e.g. the use of

readers, writers, access to digital software, are not permitted. Each application will be considered on an individual basis taking into account learning and assessment needs. More information is available on request.

Learners will be supported throughout the programme through online web-based support and individual tutorial sessions with an Academic Personal Tutor. Opportunities for learners to develop their information technology skills are available through complementary studies. This programme is supported by a VLE where students will be able to find programme / module information. Direct links to information sources will be provided from within the VLE.

To support learner's career preparations, careers personnel are available, and the students can use online resources as well. Academic Personal Tutors will also offer subject-specific careers advice through module sessions or individual tutorials.

The programme features a range of vocationally relevant assessments designed to give students the opportunity to demonstrate knowledge and understanding alongside their academic skills and practical competences. The methods used academically challenge students as well as facilitating them to demonstrate safe and effective clinical competence. A key feature of the programme is the use of extended matching questions (EMQ) in written examinations. EMQs allow for the assessment of deep learning and are a reliable and valid method of assessing clinical content.

The student's academic professional development throughout the programme will be documented through a portfolio which they will contribute to at each stage of learning. The portfolio will encourage the students to become reflective practitioners and will act as evidence of their engagement with the programme, including a minimum of 80% attendance at taught sessions for selected modules.

Formative assessment is embedded in modules at each level to support students' academic development and to help to prepare for the summative assessments.

Veterinary Nursing Clinical Skills Centre

Students have access to the equipment in this dedicated veterinary nursing facility, to support development of practical skills at Stage 1 and retention of practical skills at Stages 3 and 4.

Description of any Distinctive Features

1. The purpose of the programme is to provide a balance of vocational and academic study that is intellectually challenging, vocationally relevant, and provides a foundation for pursuing a career within the veterinary and equine-based sector; on successful completion of the programme, the student may register as a Qualified Veterinary Nurse.
2. Learners will have the opportunity to establish and refine their professional competences.
3. The programme reinforces academic knowledge and understanding, whilst supporting the development of vocational skills to equip the student with the skills and knowledge relevant to their employment. There has been substantial employer input in the design of the programme through vocational panels representing employers from the local area, thus identifying employers' needs and current skills shortages in veterinary nursing.
4. The programme has been designed to build on the competences of a wide spectrum of students. The programme delivery maximises benefits of co-teaching with

students on the BSc (Hons) Veterinary Nursing programme to allow sharing of different industry experiences.

5. For the purposes of training, students are required to enrol with The Royal College of Veterinary Surgeons (RCVS) as a student veterinary nurse.
6. In order to complete the programme and gain the highest award title, BSc (Hons) Equine Veterinary Nursing students must achieve all University module assessment and complete a minimum of 1800 hours of learning (minimum of 37 hours per week) in an RCVS approved Veterinary Nursing Training practice and complete a minimum of 2990 hours of training from RCVS enrolment to graduation.
7. Students may be eligible to apply to register with The Royal College of Veterinary Surgeons (RCVS) prior to graduation.
8. A minimum of 1800 hours of veterinary practice-based learning is a compulsory and essential feature. The veterinary practice-based learning incorporates the completion of the RCVS Day One Skills and Competences and Professional Behaviours and Attributes within the relevant module. The students are supported by their peers and the Veterinary Nursing Team to develop their skills and prepare for their veterinary practice learning. During veterinary practice-based learning students have continued support via a Clinical Tutor based at Hartpury and the University Primary Centre practice staff. University contacts and expertise are used to ensure students gain the most from this important part of the programme.
9. The distinctive nature of this programme means that students will incur additional costs over and above the expected University fees, this may include costs for return to university during their veterinary practice-based learning (travel and accommodation), RCVS enrolment and examination fees where necessary, accommodation and travel to their training practice, veterinary nursing uniforms etc.
10. The fourth year of the programme allows learners to develop further their professional skills, with particular reference to professional obligations, the RCVS Code of Professional Conduct, and Continuing Professional Development.
11. There are no part time study options available for Stage 2. For all other stages part time study options can be individually negotiated with the student.

This programme will be assessed according to the approved Academic Regulations including specific variant regulations:

Students registered on this programme will have access to the Hartpury University support and wellbeing services.
