Teaching and Learning Methods

During this module students will be introduced to the assessment, learning and teaching methods employed and will be allocated an individual project supervisor to guide them towards completion of their chosen inquiry.

Scheduled learning includes lectures and project supervision.

Independent learning includes hours engaged with essential reading, assignment preparation and completion etc. The nature of the research project will be individually negotiated and may also include work placement, by application. These sessions constitute an average time per level as indicated in the table below.

Virtual learning environment (VLE): this specification is supported by a VLE where students will be able to find all necessary module information. Direct links to information sources will also be provided from within the VLE.

Reading Strategy

Core material will be indicated to the student via pre-course material, module guides and through their accessing a dedicated VLE programme presence.

Part 3: Assessment

Assessment Strategy

The strategy will provide optional assessment briefs within the framework of a final project report to enable students to select an assessment appropriate to their subject discipline and area of inquiry. In each case, the assessment will require the student to produce a summative account of their research inquiry, including a plan for dissemination, thus providing the opportunity to meet each learning outcome. The nature of the project and assessment option should be negotiated with a supervisor prior to the commencement of the project itself.

The options are an undergraduate research article, a report on a vocationally relevant inquiry and a critical review of literature.

A student may apply for alternative means of assessment if appropriate. Each application will be considered on an individual basis taking into account learning and assessment needs. For further information regarding this please refer to the VLE.
