## **Part 2: Programme Overview**

MSc Applied Animal Behaviour and Welfare graduates can make a real and positive difference in the world of animal welfare. They have an in-depth theoretical knowledge of animal welfare and animal ethics, together with the skills to undertake, evaluate and critique cutting-edge research in this field. More importantly, they are able to practically implement real-world welfare assessments: measuring, monitoring and improving welfare standards with a keen insight into how to enact positive change via key stakeholders. They are therefore able to communicate complex topics, both orally and via written reports, to critical audiences. They are also equipped to take on more strategic roles, with the ability to assess, develop, advocate and implement standards and practices within an organisation and the sector beyond. They can use this expertise to drive beneficial welfare transformation via commercial and charitable organisations, for example, in the companion animal sector and food production industries.

## Part 5: Learning, Teaching and Assessment

### Learning, Teaching and Assessment Journey

The programme will begin by developing students' understanding of the theoretical aspects of animal welfare science, ethics and animal behaviour, but with an emphasis on the methodological application of these areas (e.g. behaviour assessment methodologies). Students will have the opportunity to put this understanding into practice in these modules, but principally application will occur within key modules in the programme (e.g. Applied Animal Welfare Assessment). In addition, they will learn the principles of managing change and understanding organisations, and then be able to apply this to the specific context of positive animal welfare change in other modules.

The MSc will use a range of teaching approaches, which will aim to support the student to develop a comprehensive knowledge and understanding of the principles and practices of animal welfare assessment. This will include a variety of didactic and discursive sessions, with academic and professional experts in their fields. Learning opportunities will be varied, with students able to apply theory to practice within learning environments on the Hartpury campus and using Hartpury animal resources. Some of the optional modules (those relating to welfare policy and legislation) are taught online.

Assessment is focused on students' ability to bring theoretical frameworks and scientific evidence to bear on practical issues, scenarios and contexts that are directly relevant to enhancing animal welfare, particularly companion and agricultural animals. It is thus a mixture of assessments designed to test their in-depth understanding of these frameworks (e.g. examinations, written essays) and their ability to use this information to problem solve and then communicate these solutions to a variety of academic and stakeholder audiences, hence an emphasis on oral assessments.

This programme will be assessed according to the approved Academic Regulations.

Students registered on this programme will have access to the Hartpury University support services.

The distinctive module used by the Programme Examination Board to inform recommending differential awards for students when considering borderline performance profiles will be:


